Withlacoochee River Electric Cooperative, INC., completed its annual Member-wide customer satisfaction survey, where 4,500 Members were asked to participate. The Member responses were sent to the American Customer Satisfaction Index (ACSI®), a company that measures customer satisfaction across multiple industries throughout the entire United States. For 2024, WREC received an ACSI score of 91, on a 100-point scale.* WREC's score is higher when compared to publicly measured investor-owned utility scores and municipal utility scores reported in the syndicated 2024 ACSI Energy Utility Study and places WREC 17 points higher than the average investor-owned utility score of 74, as well as 16 points higher than the municipal utilities score of 75, per the industry ratings.
