Ensuring Member Safety

During the summer months in Florida, working outside can be extremely dangerous, especially when you are physically active. The human body relies on its ability to get rid of heat to maintain a healthy internal body temperature. Heat dissipation happens naturally through sweating and increased blood flow to the skin. The body cools down more rapidly if the external heat and physical activity are reduced. If heat dissipation does not happen quickly enough, the internal body temperature keeps rising and you may experience symptoms that include thirst, irritability, a rash, cramping, heat exhaustion, or heat stroke. Below is a list of heat related Illnesses and their signs and symptoms to look out for. Remember to stay hydrated and listen to your body.

- Heat Exhaustion Fatigue, irritability, thirst, nausea or vomiting, dizziness or lightheadedness, heavy sweating, elevated body temperature or fast heart rate.
- Heat Stroke Confusion, slurred speech, unconsciousness, seizures, heavy sweating or hot, dry skin, very high body temperature or rapid heart rate.
- Heat Cramps Muscle spasms or pain, usually in the legs, arms or trunk.
- Heat Syncope Fainting or dizziness.
- Heat rash Clusters of red bumps on skin often appears on neck, upper chest, and skin folds.
- Rhabdomyolysis (Muscle Breakdown) Muscle pain, dark urine or reduced urine output and weakness.

- Provide shade for them.
- Keep fresh water available.
