HOUSING FOR VETERANS – Affordable housing coming to Pasco County. In June, Withlacoochee River Electric Cooperative (WREC) was proud to host the groundbreaking ceremony for the first ever Veterans Housing Community by the Pasco County Housing Authority at Magnolia Oaks. WREC, Congressman Gus Bilirakis, Commissioner Ron Oakley, Commissioner Seth Weightman, Commissioner Lisa Yeager, Savannah Sipsy, the

Regional Director at the Office of U.S. Senator Marco Rubio, Pasco County Housing Authority, and others came to this groundbreaking ceremony to support our veterans. Magnolia Oaks is being built on 9.8-acres at 7338 Massachusetts Blvd.



It will include 77 townhouse units designed to house low-income and disabled veterans and their families. Centrally located in Pasco County, the complex is within four miles of a newly constructed veterans' medical center. The project will include 34 one-bedroom units, 33 two-bedroom units and 10 three-bedroom units, a community building and a swimming pool. The facility will also be designed to provide on-site support services. "We at WREC are

incredibly excited to host and support the Veterans Housing Project," said David Lambert, General Manager of WREC and Chairman of the Pasco County Housing Authority board. "This initiative is a testament to our commitment to giving back to our community, and it is a true honor to play a part in providing housing for our veterans." Construction began shortly after this ceremony.

# Power Outage Notifications

Did you know WREC offers its Members Power Outage Notifications? Hurricane season is here! Power Outage Notifications are an important and free addition that can save our Members time and worry during a storm or outage event. While our linemen work to repair an outage, you will be informed and kept upto-date as to when the outage occurred and when it is restored. Signing up is easy through SmartHub, available on wrec.net or Members can sign up for notifications on the **SmartHub** app on their smart device. When signing up, Members can choose to receive a text, email, or both should an outage situation arise at their account location. The **SmartHub** app is a great tool for this and many other notifications. If you haven't signed up yet, please consider adding one or more of the four types of notifications offered: Planned Power Outage, Power Outage, Power Outage ETR (Estimated Time of Restore) and Power Outage Restored. All of these valuable outage notifications are designed to keep you informed if the lights should go out.

WREC's SmartHub<sup>™</sup> app allows you to manage your account at your fingertips and on the go from anywhere. Once you download the app, register and log in, you can view your account, billing history, pay your bill, check your usage and view our outage map. *SmartHub*<sup>™</sup> allows you to sign up for automatic notifications on power outages and billing items or contact us if you are experiencing an issue or have an inquiry. You can also sign up for programs such as auto pay or *Operation Round-Up*, which rounds up your bill to the nearest dollar to help fellow Members who have had a catastrophic event at no fault of their own.

With cyber security being an issue on the forefront, we are happy to share that **SmartHub**<sup>TM</sup> has a **Two-Factor Authentication** option. This option will add a level of security to the platform by sending a code to you via email or text to confirm your identity when trying to access your account. **Two-Factor Authentication** can be set up by logging into your account and selecting **Settings, Security** and then **Two-Factor Authentication** and following the prompts.

**SmartHub**<sup>™</sup> puts you in charge of your account. If you do not use **SmartHub**<sup>™</sup>, we suggest that you download the app to register and enjoy the benefits 24/7/365, yet another way we strive to empower our Members and help make their lives easier.

### **OUTAGE MAP VIEWER**

WREC offers an **Outage Map** that is live and updated continuously. Once an outage is reported, it will appear on the map.

You can view outages at any time by selecting the **Outage Center** tab at the top of our website home screen at **wrec.net** or in the **SmartHub**<sup>™</sup> app by logging in and clicking **Outage Map** at the top.

When a generator is connected to the home circuit and started up to supply power, and the home is still connected by lines to the grid, power will flow through the main breaker, back to the meter base panel, to the transformer and then energize power lines in your neighborhood. This reversal of flow is called "backfeeding " and can be very dangerous.

The safest way to use a generator is always to plug appliances directly into the generator. You can also get a licensed electrician to install a transfer switch, which prevents the generator power to backfeed into powerlines.

Another primary danger from generators is carbon monoxide poisoning. Always read and follow all safety features in the generator Owner's Manual.
