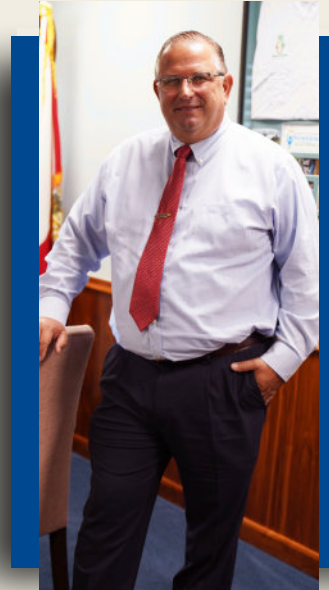

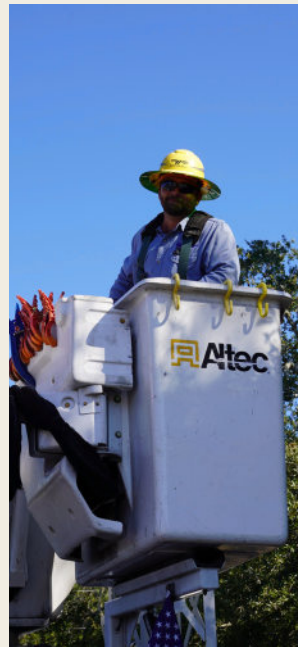

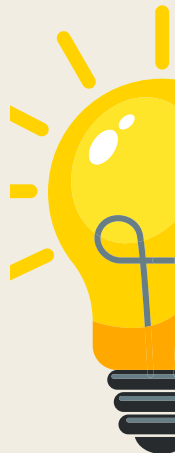
## Energy Saving Tips
